His role is to make sure these plans are meeting the needs for EMI, review and monitor fund line up and recommend changes if needed. In addition, he troubleshoots and expedites timely solutions for plan participates. 5. Renewal of Healthcare, Dental, and Vision

Employ Milwaukee would like to remain with current healthcare plan with United Health Care, the plan will increase 9.9%, Dental & Vision remain with Equitable despite the 2-year rate freeze that was guaranteed. Life, AD&D, Long-term Disability, Short-term Disability will remail with Cigna with no increase from former rate. Approved. Chytania recommended that the last PFA meeting held in November should be moved back to December to be closer to the Board Meeting, Unanimously Agreed.

6. Finance Updates

The agency currently has a cumulative positive net asset portion and a YTD surplus, this is attributed to charitable contributions and other community related events. The Financial Ratios as of 8/31/22 are at best practice for the current ratio, debt ratio, and debt to equity. There was discussion surrounding the line of credit and once EMI is paid for 2022 CDBG expenses for which EMI has had to front all of the costs up front, EMI will use those reimbursements towards paying back a portion of the outstanding line of credit.
