### 2. Chair Report

Cooperation Council of Milwaukee County (ICC) conducted a special meeting on July 20<sup>th</sup>, 2017, to discuss the request by the County Executive to assume the position of Chief Elected Official for Employ Milwaukee. The ICC members voted 13-2 in favor of retaining Mayor Barrett as the Chief Elected Official and notified DWD of the results.

# 3. President's Report

### a. Midwest Urban Strategies

This collaboration is in project management stage with three grants initially. Each of the 12 cities has agreed to a two-year commitment and paid a fee. Next phase is meeting in Cincinnati week of October  $8^{th}$ .

#### b. FoxConn

Scott Jansen and Earl Buford have been invited to a series of FoxConn planning meetings to discuss coordination of quickly onboarding viable candidates. They are scheduled to attend a meeting scheduled at UW-Parkside on September 25, 2017, along with other workforce leaders in SE Wisconsin.

### c. Trending Topics

Earl Buford informed Board members he attended the ICC meeting on September 12, 2017. EM now has a Memorandum of Understanding (MOU) with ICC. At the meeting, the ICC identified business people to serve on Board.

# 4. Committee Reports

#### Personnel & Finance Committee

Personnel & Finance Committee met August 31<sup>st</sup> and had quorum. As of June 30, 2017, had \$17.3M expenditures against a \$20.4M budget. In the administrative category, we are operating at less than 10% of program cost. Employ Milwaukee is scheduled for an audit in October with WIPFLI.

### Cost Allocation Approval

Handout - Cost Allocation Plan dated August 24, 2017

The committee reviewed the revised cost allocation plan. Updates included name change to Employ Milwaukee and removal of HIRE Center allocation by participants for space. This document is reviewed annually by auditors, DWD, and DOL.

Board discussed briefly and Pam Fendt motioned for approval, seconded by Carla Cross. Motion was carried unanimously.

### • Program Committee

Program Committee convened on August 17, 2017. Mr. Coffaro informed Board members that the standard agenda for this committee has been improved to include reporting on approximately ten items on a regular basis that will include updates from the one stop operator, local plan and practices, and reports from the Combined Core Partners.

An Open House hosted by DWD is scheduled for November 2<sup>nd</sup>, 2017 at Job Center Central.

## 5. Other

### a. Performance Report Update

Training Providers – Innovative approach is more intentional which will have the training dollars investment going to high growth/high wage focused providers.

Community Affairs – Changes have been underway enabled through technology including direct registration and mobile team to increase awareness of events. With these efforts, we hope to improve placement and wage growth.

### b. Board of Directors Binder

Mr. Jansen had his team create information binders for each board member and distributed at today's meeting. As information changes, updates will be mailed out periodically. Goal is to help ensure members stay connected to all the changes taking place at Employ Milwaukee. Chair Layden added this is a living document and encouraged board members to let Mr. Jansen know if anything should be added or removed from binders.
