#### II. Compliance

Packet information – EMI Seventh Amended and Restated Bylaws

- Employ Milwaukee Annual Review of Policies
  - In 2020, our MRA consultant was tasked with reviewing EMI employee handbook. This document (not full) includes updates in compliance, visitors, nursing mothers, as well as pandemic language. After thorough review, MRA is compiling recommendations. Sections that are still being written include paid time off, language on full-time and part-time. Plan to have PTO options discussion with Personnel, Finance and Audit Committee to get their recommendations. Still working on temporary work from home policy after discussions with other workforce boards. A 30-60-90 review for new employees has been instituted. Question was posed regarding the next steps. Response was that the Employee Handbook will be complete and ready for final approval at June 2021 Board of Directors meeting.

Agency Bylaws – Discussion

Ms. Brown has been working with EMI legal counsel at Michael Best to determine if any major changes in nonprofit realm that should be considered for our agency bylaws and learned no changes. Adding language around meeting frequency with flexibility included, i.e., may be more often or less often, etc. Julie Cayo reported that Employ Milwaukee's new Compliance Manager will be drafting a memo on bylaws that will include direct and indirect language. Important that conflict of interest form covers any potential conflict. To be clear, bylaws changing but COI form will remain the same.
