Chair Pam Fendt called meeting to order at 9:03 a.m.

#### 1. Committee Business

Tracey Luber motioned for approval of minutes from November 17th, 2021; Brian Levins seconded; approved unanimously.

#### 2. WRTP/BIG STEP Presentation

Toni White, Chief Operations Officer for WRTP/STEP presented on the mission, services, and location of the organization. The committee discussed the labor shortage and how more traditionally underrepresented individuals can get connected to quality construction jobs. Suggestions included marketing and outreach to high school students. Pam Fendt noted that there is a Milwaukee Building & Construction Trades/BIG STEP outreach event for females on Saturday, March 5th.

3. **Regional One Stop Operator Report** Beth Norris provided the Regional One Stop Operator report. Ms. Norris noted the system started not see a change in July with increased foot traffic which may be predictive of increased foot traffic for the rest of the year.

#### 4. **Program Reports:**

Vanesa Carmona-Lewis gave an update on program performance reports including WIOA Title I-B, BankWork\$, BAS Apprenticeship, Skillful Transitions, House of Corrections, and Windows to Work. Tracy Luber asked follow up questions regarding the performance metrics and providers for the House of Correction and Windows to Work programs and Chytania Brown provided clarification on the program model, which includes pre- and post-release outcomes, as well as partners which include the Center for Self Sufficiency.

# 5. Employer Engagement Updates

Vanesa Carmona-Lewis provided an update on employer engagement activities which included 16 hiring events with 535 attendees and 133 employers. Chytania Brown mentioned that the PY 20 and PY 21 metrics were impacted by the pandemic and depict more individuals looking for work so the numbers were higher during 2 years in the pandemic than they were previously.
